Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act) Lauregan Properties(the licensee) is authorised to sell alcohol from (but not on) the premises situated at **PO Box 8042, Havelock North 4157** and known as **Lauregan Wines** and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

NOTICE OF RENEWAL OF OFF-LICENCE

CONDITIONS

This licence is subject to the following conditions:

- (a) No Alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1pm on Anzac Day.
- (b) No alcohol can be delivered to a buyer or someone on the buyers behalf at any time after 11pm on any day and before 6am on the next day.
- (c) No alcohol is to be sold or delivered on Easter Sunday unless grape wine or fruit or vegetable wine made:
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.
- (d) Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday 9.00am to 5.00pm
- (e) Order forms shall require customers to declare that they are over 18 years of age or older.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition.
- (g) The holder of this licence must display on the website, in a prominent place, the alcohol licence number, expiry date and a copy of the licence for the premises.
- (h) The licensed area is described in a plan date stamped as received by the Central Hawke's Bay District Licensing Agency on 30 January 2020.
- (i) The whole of the premises is undesignated.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.
